

**AMENDED NOTICE OF ELECTION**  
**CENTRAL ARKANSAS LIBRARY SYSTEM SPECIAL ELECTION – CITY OF LITTLE ROCK**  
**MARCH 13, 2012**

Notice is hereby given by the Pulaski County Board of Election Commissioners that a Special Election will be held in the City of Little Rock pursuant to Ordinance #20,528, referred to the people of the City of Little Rock by the Board of Directors. Voters in the City of Little Rock shall decide the following:

**PROPOSED REFUNDING OF OUTSTANDING LIBRARY CONSTRUCTION AND IMPROVEMENT BONDS, ISSUANCE OF NEW LIBRARY CONSTRUCTION AND IMPROVEMENT BONDS AND LEVY OF AD VALOREM TAX**

The reduction of the existing one (1.0) mil ad valorem tax on the assessed value of all taxable real and personal property within the City of Little Rock, Arkansas which is pledged to secure the repayment of the City's outstanding Library Construction and Improvement Bonds, Series 2004A, to the new ad valorem tax rate of nine tenths of one (0.9) mil on the assessed value of all taxable real and personal property within the City of Little Rock, Arkansas, with the new nine tenths of one (0.9) mil tax to be extended and pledged as a continuing debt service tax to the repayment of an issue or issues of bonds not to exceed Thirty Two Million Dollars (\$32,000,000) in aggregate principal amount, to refund the City's outstanding Construction and Improvement Bonds, Series 2004A, and to finance the acquiring, constructing and equipping of land and additional capital improvements for public city libraries owned and operated by the City of Little Rock and Central Arkansas Library System, and to authorize the issuance of the bonds on such terms and conditions as shall be approved by the City.
